1. Notice for participants who submit papers to obey:

2015 annual conference (Fuzhou) of Chinese Association of Quantitative Economics will be divided into ten discussion groups. Each group leader (chairman in branch field) is responsible to evaluate and award papers. Scholars and graduate students who are ready to attend the annual conference need to pay attention to the following notices:

- 1) Choose the specific group according to content of the paper and send electronic edition of paper to mailbox that each group releases from the following schedule.
- 2) Label the group name on the upper right corner of your paper. For instance, Group 1 Theories and Methods of Quantitative Economics (I). At the same time, you also need to mark word number of your paper. You can only send one paper to one group.
- 3) Attach brief introduction of the author to the end of the paper, including name, gender, **date of birth**, academic degree, working place, occupation, position and contact way of author (cell phone number and E-mail address).
- 4) Note whether you are member of Chinese Association of Quantitative Economics (CAQE). If your working place is a member of CAQE, all staff and graduate students are members of CAQE.
- 5) Indicate whether you agree that your paper will be collected to public edition of Quantitative Economics in 21st Century (16th volume). Without indication, committee will regard that you have agreed.
- 6) Indicate whether you agree that your paper will be collected to China National Knowledge Infrastructure (CNKI). Without indication, committee will regard that you have agreed. We need to clarify that if your paper is collected to Quantitative Economics in 21st Century or China Proceedings of Conference Full-Text Database, you can still submit to other official journals.

3. Chairman's Responsibilities in each branch field

- 1) Collect submitted papers from participants and respond to contributors in time after receiving their papers so that contributors can confirm their own identities;
- 2) Accept consultation from contributors and send invitation letters of the conference to contributors;
- 3) Organize evaluations towards the submitted papers;
- 4) Decide name list of the participants whose paper will be discussed in the branch field;
- 5) Host the discussion in each branch field;
- 6) Recommend awarded papers according to quality of the paper and how the author presents in the group meeting. Nominate the first, second and third prize (Generally speaking, the proportion of the prizes is below 10% of all accepted papers. Of awarded prizes, percentage of the first, second and third prize should be 30%, 40% and 30% separately.)
- 7) Give comments to papers which are discussed in the branch field in closing ceremony.

Notes:

- 1) If chairman of each group can't attend the conference because of urgent and irresistible affairs, he/she need to commission a proper candidate to fulfill his/her duties and finish tasks of the committee.
- 2) Inform potential awarded participants to attend the annual conference and arrange him to give a speech.
- 3) Inform awarded participants to sit in specially appointed seats after group discussion and get him ready to accept the prize.

4. Qualifications for excellent papers in Chinese Association of Quantitative Economics

Name: Excellent Scientific Research Achievement of Chinese Association of

Quantitative Economics (CAQE)

The prizes will come out at the end of the annual conference, including the first, second and third prize. Awards will be given during closing ceremony. Qualifications of excellent papers are as follows:

- 1) Authors must be members of CAQE and below the age of 40.
- 2) Teachers and graduate students from the units that are members of CAQE can take part in the award.
- 3) The paper has never been officially published;
- 4) The author attend the conference by himself and have a discussion in his branch field.

5. Procedures of awarding excellent papers of Chinese Association of Quantitative Economics

- 1) Participants submit papers to the chairman of each group;
- 2) The group chairman organizes evaluation of papers, hosts discussion in branch field and ensures potential awarded paper contributors to discuss with group members;
- 3) After group discussion, each chairman recommends awarded papers according to communication and opinions of group members. Generally speaking, the proportion of the prizes is below 10% of all accepted papers. Of awarded prizes, percentage of the first, second and third prize should be 30% \(\times 40\% \) and 30% separately.

Standing council will discuss and decide the final official name list of winning contributors.
